All Council on Social Work Education programs measure and report student learning outcomes. Students are assessed on their mastery of the competencies that comprise the accreditation standards of the Council on Social Work Education. These competencies are dimensions of social work practice that all social workers are expected to master during their professional training. A measurement benchmark is set by the social work programs for each competency. An assessment score at or above that benchmark is considered by the program to represent mastery of that particular competency.

Data reported are from Embedded course assignment rubrics and the Field Educator's Assessment of Student Competency in SW 497 Field Education II. Data was collected across two years: Fall 2017, Spring 2018, Fall 2018, Spring 2019. The established benchmark is 90% at 3.0 on a 4.0 Likert scale. The rating rubric includes: Advanced Competence (4): The student demonstrated advanced competence of the practice behavior; Competence (3): The student demonstrates competence of the practice behavior; Developing Competence (2): The student demonstrates

developing competence of practice behavior with assistance; and No Competence (1): The student does not demonstrate competence of practice behavior.

Benchmark scores are presented for the percentage of students who have met competency (3.0 on a 4.0 Likert scale) among the 10 social work competencies. BSW program percentages have exceeded the identified benchmark in all but the following: *Apply Ethical Principles* (88%), *Engage Diversity in Practice* (78%), and *Respond to Practice Contexts* (85%). Results have been shared with Curriculum Committee and recommendations have been made to address further development of such skills.
